

5-YEAR WARRANTY

Aveo Engineering Group, s.r.o. warrants its products to be free of manufacturing defects in material and improper workmanship, provided that the product has been installed and operated in accordance with recommendations outlined in the official published Aveo Installation Manuals and Instructions or Minor Mod or STC Instructions packages as applicable. During the applicable warranty period, the Aveo Service Center will repair or replace (at its option) any Aveo parts or electronic assemblies of the unit having a defect in material or workmanship. Aveo will pay ground transportation from the Aveo factory to customer via Ground shipping services at Aveo's decision where available and international economy express when that is all that is available.

During the warranty period of five (5) years from purchase and subject to the conditions set forth below, Aveo Engineering will, without charge for parts or labor, repair or replace (at its option) any parts or unit assemblies which, in Aveo Engineering's sole discretion and final decision, are found to be defective. This warranty is void if the product has been tampered with, abused, misused, altered by the user (such as cutting off wires etc), installed improperly or operated outside the parameters of its specifications or with improper transformers, regulators or power sources such as battery chargers etc. Care should be taken to follow installation instructions and failure to do so may result in voidance of this warranty. This warranty is solely between the registered end consumer purchaser and Aveo Engineering. This warranty applies to the registered installation of the product on an aircraft for so long as that light is utilized in such registered installation and the light has not sustained any damage of any kind. The warranty is non-transferable to any other owner of the aircraft on which the light has been installed without such permission of Aveo Engineering.

Conditions: All warranty claims must be accompanied by a dated proof of purchase and by proof of registration of warranty within 60 days of purchase of the product. The online Warranty Registration Form must be completed and submitted to Aveo Engineering within thirty days of purchase via the internet at: <http://www.AveoEngineering.com>. The product must not have been previously repaired or serviced by anyone other than Aveo Engineering service facilities. The serial number on the product must not have been altered or removed. The product must be shipped, prepaid, either in its original packaging or similar packaging affording an equal degree of protection and indicating a location where the repaired product may be returned. All accessories that are enclosed with the product must be individually listed on the packing slip. Aveo Engineering has no liability for loss or damage to any accessories which are not listed separately. Defective accessories should be returned to Aveo Engineering as a separate claim item. Items repaired under warranty shall be shipped freight prepaid to the customer.

Aveo Engineering reserves the right to discontinue, modify or upgrade any products it manufactures with design improvements without prior notice and without obligation to prior purchasers.

There are no other warranties, expressed or implied, including, but not limited to, any implied merchantability or fitness for a particular use. There are no warranties which extend beyond the description on the face hereof. This warranty does not extend to damage to any property, person, plant, animal or non-product item. Warranty is void if the product is misused or damaged in any way. This warranty does not cover regular product maintenance. This warranty excludes normal LED bulb burnout and wear and tear damage resulting from accident, alteration, or misuse. Normal LED bulb burnout is a user maintenance item. If the returned product/unit/assembly failed from neglect (not defect) the customer will be responsible for all costs and shipping charges.

Please note that warranty coverage is for electronic and LED performance of the product only; surface condition is not covered by the warranty. Lights require regular polishing of their surface to maintain optical clarity. This can be achieved by polishing the polymer surface with a standard automotive soft cream polish and applying a coat of wax.

- 2) Include a description of the problem, the aircraft year and model number installed on, and the operating voltage
- 3) Include your name, address, email and your warranty registration number
- 4) Non Warranty Service: All returned freight and Customs and Brokerage fees will be the responsibility of sender or designated representative.
- 5) Warranty Service: Aveo will cover the cost of ground transportation from the Aveo Service Center to the customer via U.P.S. Ground where available in the continental United States and internationally by ground service only, unless none is available to the particular destination.

OPTIONAL WARRANTY EXTENSION PROGRAM

User may purchase extended warranty coverage of up to seven (7) years per the following table of fees:

For products purchased for more than than \$1000 but less than \$2000, extended warranty charge of \$200.

For products purchased for more than than \$2000 but less than \$5000, extended warranty charge of \$400.

For products purchased for more than than \$5000 but less than \$8000, extended warranty charge of \$600.

For products purchased for more than than \$8000 but less than \$10,000, extended warranty charge of \$800.

For products purchased for more than than \$10,000 extended warranty charge of \$1000.

IMPORTANT NOTES:

DO NOT USE: Battery chargers, battery back-up power devices, or other non certified and calibrated methods to test the aviation lights. Use of a battery charger or other power unit to test the lights will not only void the warranty but may also damage the lights.

1. **All power supplies for existing strobe lights, flasher beacons, etc. are required to be removed from the aircraft prior to the installation of the Aveo lights.**

2. **Failure to properly ground the lights voids the warranty.**
3. **Overtightening the mounting screw/bolt can damage the lights by cracking the light's lens and causing damage to the internal circuits.**
4. UV resistant PMMA/PC does not naturally discolor; it will discolor if exposed to certain chemicals and conditions. Optical depreciation of up to 10% is normal over a 20 year life of the unit. Each AveoFlash light is rated IP-66 which means it is impervious to dust and water spray. Lumen maintenance for LED's is rated at 60,000 hours and is dependent upon thermal exposure, grounding and current variance; performance is temperature and current dependent.

Please make note of your product's model number and serial number for your records. In the instance of a pair of wing lights, each wing light has its own individual model/serial combination, i.e., AVE-WPSTR-64A is a red wing position strobe model number and AVE-WPSTG-64A is a green wing position strobe model number. An online warranty number will be provided upon registration and should be noted hereinbelow for future use.
